## Requirements for Registration

### THE PARENT OR GUARDIAN MUST ACCOMPANY STUDENT

*(FBISD Board requires a student under the age of 18 can be enrolled in school only by a natural parent, foster parent assigned by authorized entity, adoptive court appointed guardian, or a person whom any of the above have granted Power of Attorney assigning responsibility of the student while enrolled in FBISD schools.)*

**STUDENTS CANNOT REGISTER UNTIL ALL RESIDENCY REQUIREMENTS HAVE BEEN APPROVED. TO COMPLETE ENROLLMENT, YOU MUST SUBMIT THE FOLLOWING DOCUMENTS:**

- 1) **PROOF OF RESIDENCY:** (3 Documents; must have name and physical address)
  - **COPY OF A DEED OF TRUST OR SETTLEMENT STATEMENT OR LEASE AGREEMENT**
  - **PHOTO ID (Driver's License) FOR PARENT OR GUARDIAN**
  - **CURRENT LIGHT OR GAS BILL**  
(no checks or other bills acceptable)
- 2) **BIRTH CERTIFICATE (or equivalent) OF THE STUDENT**
- 3) **CURRENT IMMUNIZATION RECORD OF THE STUDENT**
- 4) **WITHDRAWAL FORM, TRANSCRIPT, OR LAST REPORT CARD FROM THE STUDENT'S LAST SCHOOL ATTENDED**
- 5) **SOCIAL SECURITY CARD OF THE STUDENT**

### ADDITIONAL FORMS REQUESTED IF:

- 1) **THE STUDENT IS NOT CURRENTLY LIVING WITH PARENT(S):**  
**NOTARIZED POWER OF ATTORNEY FORM**
- 2) **THE PARENT(S) AND THE STUDENT ARE CURRENTLY LIVING WITH ANOTHER FAMILY THAT RESIDE IN STEPHEN F. AUSTIN HIGH SCHOOL ATTENDANCE ZONE:**  
**NOTARIZED FBISD DUAL RESIDENCY FORM**
- 3) **THE PARENT(S) AND THE STUDENT HAVE NOT MOVED INTO THEIR HOME WITH THE ADDRESS IN THE STEPHEN F. AUSTIN HIGH SCHOOL ATTENDANCE ZONE:**  
**INTENT TO RESIDE FORM**

**ALL ADDITIONAL FORMS MUST BE COMPLETED BEFORE ENROLLMENT**

### NOTE TO INCOMING 9<sup>TH</sup> GRADERS:

***STUDENTS WHO COMPLETED 8<sup>TH</sup> GRADE AT A FBISD MIDDLE SCHOOL AND WHO WILL RESIDE IN STEPHEN F. AUSTIN HIGH SCHOOL ATTENDANCE ZONE HAVE SCHEDULES AND DO NOT NEED TO REGISTER. IF YOU CHANGED ATTENDANCE ZONES DURING THE SUMMER, YOU WILL NEED TO REGISTER AT ANOTHER SCHOOL WITHIN THAT PARTICULAR ATTENDANCE ZONE.***
