Student Parking Permit Rules & Regulations

Requirements to receive your parking permit

- Copy of Valid Texas Driver's License
- Copy of Insurance card showing the student's name as an insured driver
- Year, Make, Model, Color, and Texas License Plate number
- No outstanding fines on the AHS Fine List
- Must be on record as a junior/senior by August 2016
- **No refunds** if requirements are not met or if permit is not used.

DISPLAY YOUR PERMIT INSIDE OF THE FRONT WINDSHIELD AT THE BOTTOM OF THE PASSENGER SIDE.

Any permits from previous years must be removed.

THE FOLLOWING VIOLATIONS ARE SUBJECT TO A \$40.00 DOLLAR FINE

- No VALID AHS permit displayed on vehicle
- Parking in a FIRE ZONE, TEACHER'S LOT, VISITOR PARKING, HAZARD (YELLOW) ZONE, HANDICAP ZONE, OR RED ZONE after 2:45 pm
- Parking in a preferred/PALS spot
- Reckless driving; driving over painted lines, passing another vehicle, cutting in line, not observing entrance/exit lanes, and running the stop sign.

Violations of the following rules will be subject to disciplinary action, a fine (\$40.), and/or loss of your parking permit:

- A 10 mph speed limit is strictly enforced on campus.
- Displaying a taped, stolen, duplicated, borrowed, revoked, forged or voided permit
- Vehicles must be legally parked in a single parking space in the student parking area only. Repeat offenders will be fined and will lose their parking privileges for an extended period of time, and could lose their parking privileges for the remainder of the year.
- **Students must exit the vehicle upon arrival and IMMEDIATELY enter the food court area.**
- Driving conduct such as reckless driving, racing, allowing a person to cling/ride on the hood/trunk of the vehicle, dangerous maneuvers, squealing of tires by force, excessive noise, and/or driving in non-designated areas shall result in administrative disciplinary action and/or loss of parking permit.
- If driving to school causes a "discipline problem" (leaving campus without permission, leaving campus for lunch, tardiness, etc.), you will lose parking privileges.
- Once inside the building students are not allowed to return to their vehicles. Being in the parking lot without authorization during school hours will result in administrative disciplinary action.
- Students leaving campus, or allowing another student to borrow their vehicle to leave campus, will be subject to administrative disciplinary action and a loss of parking privileges for up to the remainder of the school year.
- If officials of the school district have reason to believe you have anything in your vehicle that is in violation of the law or FBISD board policy, you may be requested to open your vehicle for a search by a school official.
- **The "Red Zone" which encompasses a portion of the student parking lot area is designated as the marching band practice area. Failure to remove your vehicle from the Red Zone by 2:45 pm shall result in a \$40 fine and a loss of parking privileges.**
- The purchasing or selling (borrowing or loaning) of parking permits, the attempt to purchase or sell a parking permit, or any attempt to circumvent these regulations will result in the forfeiture of the permit, loss of the money spent, loss of parking privileges, and will result in administrative disciplinary action as well as possible police action. **Parking stickers are non-transferable and cannot be given, sold, or loaned to any other student. Students cannot register for, or purchase parking stickers with the intent to give or sell the sticker to another student.**
- If you change vehicles during the school year, you must come in office 107 and provide the new car's information. We will need new proof of insurance (showing student's name), new license plate number and new car make, color, and model. Failure to report any vehicle changes will result in a fine of \$40, and may result in the loss of parking privileges. (Bring in the old sticker to get a new sticker – no student will be issued two stickers.)
- **If for any reason you drive a vehicle to school other than the one registered at school, YOU MUST upon arrival (before 1st period) to school come into office 107 and sign in your vehicle or face a possible \$40 fine. YOU MAY NOT drive to school a vehicle that is not included in your insurance policy.**
- If you are caught using a permit that is not your own, besides receiving a \$40 fine you may receive further disciplinary action.
- **If a student with a parking permit needs to leave school during the day, the student must bring a permission note with a signature from the parent /guardian to the attendance office. The note needs to have a phone number that can be called to verify that the student is allowed to leave campus. Students will not be allowed to leave campus without following proper procedure.**
