No one with a fever of 100.0 F or higher or other signs of illness should be on the campus.

Maintain social distance (at least 6 feet apart at all times)

Wear a personal protective face covering (cloth or disposable) while in buildings and/or when in close proximity to others or in common areas

Wash hands often, for 20 seconds or more, or utilize hand sanitizer (60-95% alcohol) if soap and water are not available.

Report to Deb Erhart (<u>Debra.erhart@fortbendisd.com</u> or 281-634-2779) any concerns that arise regarding possible exposure to someone who has tested positive to COVID-19 within 5 days of observation.

## Fort Bend ISD Required Health and Safety Protocols

All student observers adhere to the following protocols when reporting to any FBISD campus.

- ▶ If you have a fever of 100.0°F or above or other signs of illness, do NOT go to a campus.
- > Comply with screening by the Wellness Monitor upon entry to any FBISD campus.
- > A personal protective face covering (cloth or disposable) is required while in buildings and in close proximity to others or in common areas.
- ➤ Maintain social distance (at least six feet apart) at all times.
- > Wash hands often, for 20 seconds or more, or utilize hand sanitizer (60-95% alcohol) if soap and water are not available.
- > Practice routine cleaning and sanitizing.
- > Complete the survey the same day observations occur.
- ➤ Report to Deb Erhart (<u>debra.erhart@fortbendisd.com</u> or 281-634-2779) any concerns that arise regarding COVID-19 and your campus visit.

- Do NOT contact campuses/teachers personally.
- Do NOT observe until cleared.
- Only go to the campus you are assigned.
- Only go to the campus if you are healthy, have not been in contact with someone with COVID-19 in the last 14 days and have not traveled in the last 14 days.
