Grading system

Daily work - 50% (class assignments, notes, homework, quizzes, vocabulary, etc.)

- III. Quizzes will be given regularly throughout a unit. Be prepared.
- IV. All work must be turned in on time. Any work turned in after the assigned due date will receive a late penalty of 2 points per day until the end of the 9 weeks.

Tests / project – 50%

- I. 2-4 test grades will be given per 9 weeks.
- II. Projects count as a test grade. Guidelines and a grading rubric for each project will be given at least two weeks prior to due date.

Late Assignments Policy

I will accept any assignment assigned during the grading until report card grades are due with late penalty of 2 points per day after the initial due date (excluding extenuating circumstances). I will not accept any assignment assigned during this grading period after report card grades are issued.

Absence policy
