

 - Secure district demographer
 - Prepare elementary boundary scenarios based on existing data and vet by updated demographic study
 - Create and convene a district-wide study team that will advise the administration on establishing elementary school boundaries to best utilize all schools

August 12 Deliverables

- Recommendation to Board for approval of an RFP proposal for demographic services as early as September

- August 12-14: District Leadership engages in strategic planning process to develop vision, mission and goals
- September 18: Community Engagement meetings begin to enable our stakeholders to engage in the development of a District Strategic Plan to assess educational adequacy of FBISD facilities to support the District's instructional program
