3.6.3 Requirements for a Student to Be Considered Present for FSP (Funding) Purposes –2021-2022 SAAH--condesed version

- 1. Is enrolled/attending off-campus **dual credit program** courses and is not on campus.
- 2. Is participating in an **off-campus work-based learning** opportunity.
- 3. Is enrolled **full-time** in **TxVSN** courses.
- 4. Is participating in an **activity** that is approved by your local school board and is under the direction of a district professional staff member, an adjunct staff member, or a para
- 5. Is participating, with local school board approval, in a short-term (for example, 5-day) class that is provided by the **Texas School for the Blind and Visually Impaired** (TSBVI) or the Texas School for the Deaf (TSD) at a location other than the student's campus.
- Is participating in a mentorship approved by district personnel to serve as one or more of the advanced measures needed to complete the Distinguished Achievement Program (DAP) outlined in 19 TAC Chapter 74.
- 7. misses school for **observing district-approved religious holy days**, including 1 day travel to and 1 day travel from religious site.
- 8. Is in grades 6 through 12 and misses school for the purpose of sounding "Taps" at a military honors funeral held in Texas for a deceased veteran.
- 9. misses school for the purpose of attending a required **court appearance**, including traveling for that purpose (1 day to and 1 day from court appearance).
- Is in the conservatorship of the DFPS and misses school to participate in an activity ordered by a court or attend an activity under a service plan (Texas Family Code, Ch. 263, Subch. B) including 1 day of travel to and 1 day from activity.
- 11. Misses school for the purpose of serving as a student **early voting clerk**, if your school district has a policy allowing for this type of excused absence, or misses school for the purpose of serving as an election clerk or student election clerk.
- 12. Misses school for the purpose of appearing at a governmental office to complete paperwork required in connection with the student's application for US citizenship, including traveling for that purpose (1 day to and 1 day from the office).
- 13. Misses school for the to take part in the student/parent/ or guardian's US naturalization oath ceremony, including 1 day travel to and 1 day from ceremony site.
- 14. Is temporarily absent because of a documented, face-to-face or video appointment for the student or the student's child that is with a health care professional licensed, certified, or registered by the State of Texas to practice in the United States.
- 15. Is in his or her jr./sr. year and misses school to visit an institution of higher education.
- 16. Is absent to visit with a parent/stepparent/legal guardian who is an active duty member of the uniformed services on active duty/on leave from/immediately returned from continuous deployment (at least 4 mos) outside residence of par/steppar/guardian.
- 17. Is 17 years of age or older and **pursuing enlistment** in a branch of the United States Armed Services or the National Guard.
- 18. Is absent due to a medically, documented **serious/life-threatening illness/treatment**
- 19. Is obtaining driver's license or learner permit and is 15+ years old
