The Board of Directors and staff of the Fort Bend Education Foundation (FBEF) are pleased to present this Annual Report of the Foundation's accomplishments and activities during the 2018–2019 fiscal year. During this time, the Board reviewed strategic plan recommendations from Rice University Jones Graduate School of Business Capstone

Program students and adopted a new strategic plan to carry the Foundation through 2023. This is the second time the Foundation has worked with Rice Business for strategic planning purposes and we are thankful for the partnership and excited about a few new ideas we will be exploring in the coming year. The Foundation mission remains unchanged under the plan: to enrich and enhance the quality of education for all Fort Bend ISD students by funding and awarding grants for teachers, school sites, staff development and district-wide programs and initiatives. I am proud to report to you that the Foundation continues to exceed the goals and expectations set during planning; in 2019, we awarded \$811,341 to FBISD teachers and schools through all of our grant programs, which is more than double the amount awarded five years ago.

With overwhelming community support, our signature events continue to fuel this tremendous Foundation growth. Our 19th annual Back to School Scramble, 4th annual Sugar Shindig, 26th annual Gala, themed Disco Fever, and 16th Education Expedition bike ride all shattered records in funds raised!

We continue to assist the District in its mission "to inspire and equip all students to pursue futures beyond what they can imagine." In 2018–2019, FBEF awarded 344 grants, or \$555,661, to support the Grants to Teachers and Schools program. Additionally, the Foundation awarded \$16,600 for New Teacher Gifts, \$43,500 in professional Development Grants, and \$195,630 in Pass-through Grants. Heading into its 27th year, FBEF has awarded over \$36 million in grants to FBISD teachers and schools. Through these programs, we can confidently say that we truly do touch every school in FBISD!

On behalf of FBEF's Board of Directors, we would like to express our heartfelt appreciation to all who have supported, volunteered, and served our Foundation, for your ongoing friendship, commitment and dedication. It is my honor to serve as your Board President. Thank you for your significant and life changing support in enriching the lives of our Fort Bend ISD Students. 

Who decides how the money is spent?

The Foundation's Allocation Committee is responsible for the solicitation, review and acceptance of proposals for projects and programs that will improve and enrich classroom education.

Since its inception, the Education Foundation has awarded nearly \$36 million in grants to FBISD teachers and schools.

Where does the money go?

Every school in Fort Bend ISD benefits from the Fort Bend Education Foundation grant programs that train teachers, provide equipment, and offer new instructional experiences to students of all ages. Each year, hundreds of grant proposals are submitted to the Education Foundation. Each proposal undergoes an extensive review process. The number of grants awarded depends upon the amount of money raised through the Education Foundation's annual fundraising events.

This year, the Education Foundation awarded 344 grants for \$555,611 to support the Grants to Teachers and Schools program. Additionally, the Foundation awarded 166 new teacher gifts for \$16,600, \$43,500 in professional development, and \$195,630 in passthru programs.

GRANTS IN ACTION

Neill Elementary School (Math) — Mastering the Multiplication Madness

With new math centers geared toward math fact fluency, students enjoy the process of "traveling" down the R.O.A.D. to Success. They challenge themselves and encourage others along the way. Students love the diversity of each activity and feel more confident about their fluency.





Kempner High School (Library) — Kreation Lab

The *Kreation Lab* provides the library with the space and tools needed to launch a makerspace. Here students have an opportunity to incorporate meaningful exploration and make connections with **S**cience, **T**echnology, **E**ngineering and **M**ath by experimenting with robotics kits along with various other activities. The *Kreation Lab* will continue to transform the library in the 21st century.

Christa McAuliffe Middle School (Career and Technical Education) — The Fruit of our Looms

With the materials provided by this grant, students are able to understand the roots of new and evolving technology, as well as, the skeleton of the engineering behind their clothing. Students learn the "how" behind the



creation of the fabrics, the history that started it all, and appreciate the privileges we have today when purchasing these items in a store.



Walker Station (Reading/ ELA) — Read with Me Independently! Part Deux

Students take multiple books home on a nightly basis to read with their parents. A direct result of implementing these guided reading books is an increase in the students' interest in reading as well as their reading ability.

Dulles High School (Multidisciplinary) — Nspire the Dulles Decathlon

Students on the Decathlon Team practice and compete with the same type of calculators they use in their math classes. The ability to compete with a calculator they are comfortable and skilled with provides students with a huge edge in math competitions requiring speed and accuracy.
