I. Welcome

Mindful Moment– Allison Thummel, SHAC Chair

Allison called the meeting to order and started with a mindful moment.

II. FBISD bond video presentation-Long Pham, Chief Information Officer Overview of bond components that are pertinent to SHAC—Chris Juntti, Interim Chief Operations Officer bond components related to SHAC-playgrounds, walking tracks, clinic renovations, drinking fountain replacement, new intruder detection, tennis court renovations, baseball field renovations, locker room renovations, kitchen upgrades

Questions/Comments

Q. Lighting can make a difference in well-being of students-that component of the bond is pertinent to SHAC A. Chris-New lighting will be more conducive to learning –phasing out fluorescent lighting

Q. Is there anything in this bond package for furniture—stand up desks, etc?

A. Chris-Furniture refresh is part of the bond—typically that is new student seating and teacher seating

Q.This committee has previously talked about alternatives to typical student desks. Is that in the bond? A.Chris-Flexible seating is advantageous

Grayle James-as mother of very tall student—they don't always fit into the desks Chris-There is seating and furniture refresh in the bond

Q. What are some of the limitations of the bond-cannot cover salaries, etc

A. Chris-The bond side has statutory limit on things we can pay for—bricks and sticks—buildings and what goes into those buildings

Salaries cannot be paid for with bonds

Q. What happens if this bond doesn't pass

A. Chris-indirect negative effect—for example Clements is still safe for our students, but the district will continue to deal with structural issues as it continues to sink

If bond doesn't pass, district will continue to do what we can for maintenance

If we have to use the general fund to pay for it then every dollar spent on repairs, etc.. is a dollar that can't be spent on salaries or educating kids

Long Pham—some of the software used in the district are outdated and are not supported, so the district has to figure out how to fix these broken things

B. Community Health Assessment- FB County Health & Human Services

Carrie Rai MA, MSW, LMSW, Performance & Innovation Specialist

Mission is to promote and protect health and well-being of residents of Fort Bend County through disease prevention and intervention, public health emergency preparedness and response, community engagement, and helping to assure the equitable provision of basic human needs

-Conducted surveys within the county and interviewed key informants in the community to understand community health needs

-Obtained several data metrics—looked at over 200 pieces of data—compared what is available from CDC to what Fort Bend community said

-where there was crossover, those items were red flagged

-identified 5 major needs in the community

Mental health, housing, obesity, heart disease and prenatal care

-Developed a community health improvement plan-included community input to discuss problems and come up with strategies/solutions

-GOAL -then measurable objectives then strategies

GOALS

-Improve mental health by increasing access to services and providing education

-Endure safe and affordable housing units are available for ownership and rent for the present and future residents of Fort Bend County

-Improve health by decreasing obesity rates

-Improve cardiovascular health by increasing awareness and access

-Prevent pregnancy complications and maternal deaths and improve women's health before, during and after pregnancy

-developing strategic plan within the health department –SHAC Can read the CHA &CHIP (see slides)

Questions/Comments

Q.Were the needs ranked in order of most to least? A.Yes

Q.I'm surprised that finances didn't rank in the top 5. Studies show that a lot of mental health issues stem from financial issues.

A.When the community reaches out to our department for mental health assistance, we do recognize that there is a connection to financial issues and work to address those (uninsured, underinsured)

Q. It takes finances for low income people to eat healthy and would like to see those addressed more.

Q.Surprised that under obesity no strategies were targeted toward elementary schools A.The obesity strategies are addressed under heart disease as well and they address a younger age

Q.How was information gathered?

A.Surveys were administered at outreach events, sent out electronically-received 845 responses Didn't have capacity to do a large campaign so there were some limitations with that If you do have input, please share contact info with us

Through the challenges we experienced during COVID, it gave us a larger footprint—we try to widen our connection and welcome feedback

Hope to do another community feedback in 5 years to capture the evolving and changing themes

Q."Middle income" has become financially challenging—any plans to start community gardens at high schools that community members can access to have fruits and vegetables? A.We do have a new chronic disease prevention program to educate community on nutrition—trying to partner with organizations to help with community gardens and access to fresh fruits and vegetables Had to scale up department rapidly to meet the needs of the growing Fort Bend community-so still working on partnerships-connect with us to do presentations in schools, etc.

Q.Can county look into providing resources so schools can start community gardens? A.Our department funding is limited to providing resources -try to leverage what we can through mutual relationships (foundations, etc.)

Q.I think this is great dialogue. FBISD is bringing concerted efforts to address the access piece to our families access to fresh fruits and vegetables and food insecurity—Brighter Bites, Shared Dreams A.CHIP is a community plan and needs to partner with community organizations

Q.Any conversations of in-patient mental health facilities in Fort Bend County? A.Will give contact for someone who can provide additional information on that

A. Getting to Know the Advocacy Subcommittee: Rocaille Roberts

Rocaille will look at the County CHIP and look for areas of alignment Advocacy Sub-committee began with Texas Legislature session in 2021 4 Key Goals (see slides) SHAC Advocacy Resources (see slides)

SHAC's Take Action project

-SHAC Action sub-committee collected feminine hygiene supplies and toiletries for Shared Dreams—will be shared with campuses

A. The Education Ecosystem in Texas & Legislative Update

Dax Gonzalez, Division Director, Texas Association of School Boards, Governmental Relations (not able to attend--presentation given by Chassidy Olainu-Alade, FBISD Coordinator Community and Civic Engagement-Communications and Koby Willbanks, FBISD Legal Counsel)

-Regular updates are provided by lawmakers, regulatory boards and agencies, local education agencies -Several layers of advocacy—local levels often carry more weight than trying to get to the state levels -At the local level, school board members –don't forget about local agencies for advocacy

-Student engagement—Chassidy meets with student leaders and student groups and teaches them techniques for advocacy—ie registering to vote, how can a student register and how can they help others register, what are requirements for registering -cast a broad network (parents, grandparents)—giving them a voice in their community

-Current legislative state session-don't also forget about federal level

-How do we advocate? Understand legal boundaries for advocacy

-School district employees are limited—cannot spend public funds to advocate for an issue—as a community citizen, employees can engage in advocacy outside of their official duties -district can spend funds to lobby

-Most important thing is to vote-in all elections, local and national -Stronger impact in elections with lower voter turnout—May election typically has low voter turnout (8,000-10,000)-advocacy efforts for these elections can have a large impact

-Relationships with legislators at all levels—if they know you and know your role and your expertise, your voice carries more weight---start building relationships early not just when issues come up Stay engaged

-Advocacy doesn't just stop at the capitol

-Legislative issues current legislature

- *teacher shortages
- *student enrollment

*state revenue surplus—advocating for some of this money to go to education—competing priorities property tax relief

*school safety and facilities

-MyTLO -sign up to get email updates to stay informed about what is happening in state legislature (My Texas legislature online)

-Not a lot of bills related to schools have passed yet, so this is a good time to get engaged
