UnitedHealthcare Zero Cost COVID-19 Medical Services	 COVID-19 TESTING and testing-related visits at Physician Offices, Urgent Care Centers, and Emergency Department Waive member cost sharing, including copayments, coinsurance and deductibles, for approved and authorized COVID-19 testing and testing-related visits at physician offices, urgent care centers, and Emergency Department for members enrolled in comprehensive medical plans, and Medicare managed care plans. Testing must be provided at approved locations in accordance with U.S. Centers for Disease Control and Prevention (CDC) guidelines. Coverage will include in and out of network and relies upon accurate COVID-19 coding. Virtual Visits – Waive Cost Share for designated providers (Amwell, Doctor on Demand, Teledoc) Waive cost share for <i>all</i> Virtual Visits, not limited to COVID-19 until June 18, 2020. This also applies for HDHP with HSAs. This change will only apply to customers who have Virtual Visits through UnitedHealthcare. Applies to all FI and ASO plans. A plan change is required to add new Virtual Visits coverage through UnitedHealthcare. (English flyer, Spanish flyer) Telehealth – Expanding access for virtual care to all In Network providers Effective immediately, until June 18, 2020 all eligible in and out of network (if applicable) medical providers who have the ability and want to connect with their patient through synchronous virtual care (live video-conferencing) can do so. Claims for treatment will pay according to the member's plan benefits, applying the applicable member cost share. We will waive member cost sharing for COVID-19 testing related visits.
Kelsey Virtual Visits for Medical Services	In response to the guidance of public health and government officials to reduce in-person interactions, Kelsey-Seybold Clinic has made the decision to schedule patient appointments as Virtual Visits, effective immediately, whenever possible, for both primary and specialty care. "Virtual Visits" include Video Visits, Telephonic Visits and E-visits. Please know that our clinics will remain open and physicians have the availability to schedule an in-clinic appointment if necessary, after a patient's Virtual Visit. Diagnostic testing will also continue to be available for patients if directed by their physician.
	Virtual Visits allow patients to select a specific Video Visit for COVID-19 symptoms, as well as visits with primary care and specialty care doctors for a broad range of symptoms and conditions not related to COVID-19. We know that Virtual Visits are new to many patients. To assist our patients, our 24/7 Contact Center (713-442-0000) is standing by to help.
