>Angie Hanan suggested using the number of economically disadvantaged students in FBISD in LP 4 since the numbers from Fort Bend County regarding food insecure homes will be delayed-further discussion about this and it was decided to use both sets of numbers

>Doug Earle commented that the recommendations are generic

-Allison commented that she believes this is a good first step for SHAC and in the future the LPs could have more “meat”

-Angie commented that these are a good first group of priorities and provide good talking points for reaching out to legislators

-Rocalle Roberts commented that they were drafted to allow more flexibility to adapt to what the legislature discusses

>Pearl Lam asked if these will be updated on an annual basis?

-Allison said the summer before the next legislative session SHAC sub committees will work on their priorities with the hope that they can be included when the BOT votes on their priorities

>Rocalle-if these are approved they can be presented to the BOT for their recognition and acknowledgement—this provides more substance when we advocate as individuals and is a pathway to be even stronger in preparation for 2025

>Kim Taylor asked about the timeframe for members to give input on the legislative priorities

-going forward it can be adjusted

>Suggested bullets to add to LP4: Whereas Fort Bend County finds that XX children in Fort Bend County live in food insecure homes;
