I. Welcome

B. Importance & Relevance of Public Hearing #2

>This is the 2nd public hearing and if there is a quorum, there will be a vote today on the prevention support materials. If voted on by the SHAC, it would next go to the Board of Trustees in April and if approved will be available for use on campuses beginning in May.

II. Presentations

A. Summary of Prevention Support Materials– Lori Sartain, FBISD Assistant Director of Health & Wellness

>Senate Bill 9 requires the Board of Trustees to determine specific prevention resources that can be used on campuses on the topics of child abuse, dating violence, sex trafficking and family violence.

>Once approved by the Board of Trustees, the resources will be immediately available to campuses.

>Policy EHAA local outlines the curriculum adoption process (see slides)

1. Board adopts a resolution--Occurred on Nov. 22

2. Two public meetings-Feb. 15, 2023 and March 21, 2023

3. SHAC provides recommendations to the board-April 17, 2023

4. The board will act on the adoption recommendations-at April 17, 2023 meeting, the board will vote to approve the materials or not approve

>task force met 4 times since Nov. 22—used evaluation rubric to review and evaluate resources

>presentation of recommendations (see slides)

>Timeline

-Public meeting #2-March 21, 2023

-Board meeting presentation and vote-April 17, 2023

-Resources will be available to campus beginning April 18 if the board approves the resources

>Angie Hanan-There is an extensive list of resources available. Are the available to campuses to use when needed?

Lori Sartain-all resources are opt-in according to law-resources can be used for very specific situations and schools can use what resources they need for their campus-materials will be available to schools beginning April 18 if board approves

>Cathy Hunter-If the materials are available beginning April 18, how will the opt-in process work?

Lori Sartain-law requires parents to have 14 days' notice to opt-in—opt-in materials are ready for teachers to use—only those who have a signed paper can receive instruction

>Angie Hanan-Is there a cost for the programs?

Lori Sartain-the district is not required by law to provide the resources-they are above & beyond the TEKS-all programs are free to the district

FBISD SHAC 2022-2023

- >Doug Earle-If parents don't opt-in, what do those students do during the instruction time?
Lori Sartain-students who aren't opted-in will be provided with activities during the instruction time
- >Angie Hanan-Do campuses have easy access to data about who has opted-in?
Lori Sartain-beginning next year the opt-in form will be part of the beginning of the year forms and will be easy for campuses to run a report to see who has opted in. For this year, it will be a physical permission slip. The information will still be sent home 14 days prior to instruction.
Campuses identify their needs & use resources to support those needs
- >Dana Tran-does the opt-in form have to be filled out every year?
Lori Sartain-Yes, Senate bill 9 requires a new opt-in each year
- >Rocaille Roberts-Is there ever an opportunity to revisit resources and vet new ones?
Lori Sartain-SHAC executive board will discuss possibly creating a review cycle to review materials
- >Doug Earle-How does a campus identify which program is best for them?
Lori Sartain-social workers & mental health counselors, in addition to Lori and LaDonna will work with campuses & vendors
- >Natalie Bostic-Since opt-in papers will be signed at the beginning of the year starting next year, will parents receive information about the programs before they consent?
Lori Sartain-parents will be able to review resources individually and choose to opt-in or not—also 14 days prior to instruction, parents will also get notice and can choose to change their selection at that time
- >Sandy Bristow-Will vendors send out trainers?
Lori Sartain-vendors provide staff to do the presentations

- >Further details on the 14 days' notice—parents will be given an email address and if they changed their mind and don't want their child to take part in the presentation, they will be an email address of someone to contact to change their selection
