February 28, 2024 Meeting Agenda

Theme: Wellness-Centered Leadership

- I. Welcome & Mindful Moment Allison Thummel, SHAC Chair (12:00-12:10)
 Allison opens the meeting at 12:01 pm with a wellness moment to consider self-care, personal satisfaction, and compassion for others.
- II. Presentations and Brain Break (12:10-1:15 pm)
 - A. FB County, Kaila Williams, MPH, MEP, CPH, Director-Health Communications, Education & Engagement, Fort Bend Health & Human Services Following the presentation, a QR code for community feedback was shown on the screen and a flyer with the QR code was passed around. The presenter seeks ideas on how to address health priorities.
 - B. Wellness Policy Triennial Review, Lori Sartain, FBISD Director of Behavioral Health & Wellness

Allison explained prior to the presentation that SHAC must have a triennial assessment every 3 years. Lori presented data on the Wellness Policy and the assessments used across campuses. If any SHAC members would like to participate in the Wellness Plan Task Force, contact LaDonna Green. Also, the policy will be shared once it is completed.

Q: For opportunities to get involved, it is for the rest of this school year? A: No timeline required. We'll meet soon and determine the timeline.

- C. Brain Break, District Student Wellness Coalition
 Students from Austin High School explained and lead a game of Kahoot!
- D. Campus Safety Update-David Rider, FBISD Chief of Police

Chief Rider talked about the presence of security guards at elementary schools. The 88th legislative session made it a requirement to have an armed officer on every campus in the state of Texas. FBISD already had an officer at every high school and middle school. There are 51 elementary schools in FBISD and a shortage of police officers in every agency. He shared and explained the options for officers at our elementary schools: guardian, marshal, and private security; the best option for FBISD is to hire private security. He also emphasized the importance of building relationships between the officers and students, staff, and community.

Q: How do you monitor security guards, and can you change them out?
A: FBISD has contracts with 2 companies. Principals communicate issues with
FBISD Police Department. FBISD has the right to ask the contracted companies for a replacement.

Q: Are there currently 50 officers in all elementary schools? A: Every campus has been covered since January 4, 2024.

E. Fentanyl Awareness Prevention-Lori Sartain

Senate Bill 629: FBISD currently has NARCAN at every high school and middle school campus. Nurses and officers have been trained in how to use it, and principals will be trained soon.

House Bill 3144: October is Fentanyl Poisoning Awareness Month.

House Bill 3908: Each school district must provide education to students in 6th-12th grade annually.

Lauren Ibekwe with Fort Bend Regional Council spoke on the 36-minute video lesson that was created for 6th-12th grade students as well as additional drug prevention

education and tools that is available from the council. There is also a youth coalition that meets every other Thursday. Discussion and Q&A followed.

Q: Would you be a good person to come to a wellness event? A: Yes

Q: Is the lesson geared toward students? Parts of the video seemed geared for parents.

A: The video was created for student education.

Q: How big is the problem in FBISD or county? A: There are no specific numbers for fentanyl—unable to capture since fentanyl is in other substances. Other substance use is lower than the national average. Vaping is the biggest reported problem locally.

Q: Why is it not shown in elementary school? A: The council was specifically asked to create education for 6th-12th grade. There is other curriculum available for elementary students.

Q: Is there any room for editing the presentation? A: Yes. The council welcomes suggestions.

Additional comments: It seemed long and maybe add a list of resources. Resources are available on the website and via QR code at the end of video. It needs a hook at the start of the video to get the audience's attention. Local data and stats could be included in the video. Stats were intentionally left out because they are less relatable for students.
