

FBISD School Boundary Oversight Committee Meeting Summary Thursday, May 20, 2021 6:00 p.m. – 8:00 p.m. Meeting conducted via Zoom

The School Boundary Oversight Committee (SBOC) of the Fort Bend Independent School District, consisting of members from each of the eleven feeder patterns, convened for a meeting on Thursday, May 20, 2021, at 6:00 p.m. through the Zoom online platform.

## Purpose:

- Serve in an advisory role to staff
- Review and provide suggestions regarding attendance boundary recommendations
- Align work with Decision Principles as stated in Policy FC (Local)

	Facilities Master Plan determines the long-term need of the district and requires Board approval			
	for the more financially significant needs such as additions to schools and new schools.			
	4. Attendance Boundary Process was adopted by the BOT in 2019. The Facilities Master Plan is			
	one of the primary indicators showing rezoning needs.			
	Dr. Indelicato presented a brief analysis of the projected growth of the feeder patterns in the			
	southeastern sector of the district, including the 10-year demographic update provided by PASA.			
	He informed the committee that the efficient utilization of facilities is 80-100%. The review			
	included slides detailing PASA's long-range 10-year plan summary, demographic update, and			
	facility over-utilization projections.

	A. The Annual Enrollment Review presented in the fall included scenarios where are all students

Attendance Boundary Process	campuses with available space as short-term relief until the campus is completed. A second example presented was Elementary school 52 (unnamed), which will relieve Palmer and Parks ES. The example shows the short and long-term recommendations for relief. The recommendations are to utilize elementary campuses in the Marshall and Willowridge feeder patterns to implement innovative instructional programs, including the Early Literacy Centers. Two new elementary schools are recommended for the RPHS feeder pattern. Land for the campuses was procured in August 2020. Other recommendations included developing a flexible scheduling proof of concept for RPHS, rebalancing RPHS, and HHS enrollment and construction of Middle School 16. Dr. Indelicato detailed the new 8-step SBOC Attendance Boundary process, which was revised					
	based on the results of last year's public hearings. The decision principles outlined in the process will help shape the final recommendations.

Construction on a school that is unfunded can begin no earlier than 18 months before a bond is passed. Payment would come from the FBISD general fund. If a proposed bond passes, the fund is paid back. If the bond does not pass, other decisions must be made.					
	Q. When will the next bond be presented? Q. It is unclear; however, bonds are called in May and November election cycles. The earliest bond possible bond proposal would be presented in

Discuss Fall and Public Hearings	Dr. Indelicato discussed the School Policy Decision Principles per district policy and reiterated the critical and primary factors explicitly considered in making the attendance boundary changes. Managed the expectations on these primary factors. Clarified each point. Reviewed the slide describing the public hearing. The intent is to allow a significant amount of time to hear from the community. The public hearings will mirror school board meetings allowing attendees to sign up for a predetermined amount of time to speak.						



	Dr. Indelicato acknowledged that some of the committee members were not in attendance. (about half) and that a makeup session will be scheduled for those who were unable to attend. Those who can no longer serve on the committee will be replaced with new members from their respective feeder patterns so that all feeder patterns are properly represented. The makeup orientations will likely be scheduled for late July/early August.

## **Chat Questions:**

How detailed is the data that is provided?

The last PASA update I reviewed was about 300 pages. It was extremely detailed and helpful.

The March 22, 2021 PASA presentation showed projected enrollment numbers by school and utilization numbers. Their utilization numbers differ from the annual enrollment review functional and social distancing capacity. Can you please explain the difference?

What trends have we noticed from the 2018 PASA update versus the 2021 update? From my memory, the suggested needs presented in 2021 are the same needs we were told would be needed in 2018. Will we get/need detailed information behind capacity calculations for our SBOC work?

What is a reimbursement resolution?

For the FMP Rec 9, why does the district-wide review of all high school boundaries in fall 2022-23 come after HS 12 boundary work fall 2021?

When will the bond be called for MS 16? Did the slide say that boundaries for the middle school would be worked out this fall?

Is this process like the Facility Steering Committee process?

Are our commitments as they were originally planned or are, we adding a year given the break? Can we be provided with copies of PASA PowerPoint slides?

Do we have a list of SBOC members by feeder?
