## **Meeting Objectives:**

- SBOC members will understand roles of officers and committee members regarding the attendance zone process.
- SBOC members will review and understand the PASA demographic update, Annual Enrollment Review, and the Facilities Master Plan.
- SBOC members will understand the purpose of ThoughtExchange and public hearings.

## Success Criteria:

- SBOC members will be able to articulate their role and that of SBOC officers.
- SBOC members will gain a clear understanding of the PASA demographic update, Annual Enrollment Review, and Facilities Master Plan presentations and connect them to the work of the SBOC.
- SBOC members will be able to understand how the community input collected in public hearings through Thought Exchange impacts the work of the SBOC and the attendance boundary process.

On September 27, 2022, the SBOC convened in the Administration Building Board Room. Beth Martinez welcomed everyone to the meeting and made introductions of the Executive Leadership team and staff present. HEB donated food trays for the SBOC. Topics of discussion included:

- Staff went over SBOC Member Commitments stressing the importance of attendance.
- Resources available, including Policy and Procedures, the District website, and the use of Microsoft TEAMS.
- The roles of officers and the opportunities available to nominate or self-nominate.
- Long Range Planning Process including the Demographic Report, Annual Enrollment Review, and Facilities Master Plan and how they all come together to develop the Original Recommendation.
- Attendance Boundary Process broken out in steps per Policy FC(Local).
- ThoughtExchange and how it works and how it is used to collect community input for the public hearing.
