The School Boundary Oversight Committee (SBOC) of the Fort Bend Independent School District, consisting of members from each of the eleven feeder patterns, convened for a meeting on Thursday, November 18, 2021 at 6:00 p.m. through the Microsoft Teams platform.

Purpose:
