# Middle School Summer Programs

#### 2025 Middle School Remedial Course Offerings

The Remedial Middle School Summer program will be offered for one June session only. Two courses can be taken during the session. Students who need to repeat two courses must successfully complete both courses in order to be promoted to the next grade level based on grade placement committee decisions.

Summer School is offered to students who did not successfully complete courses previously taken in grades 6, 7 or 8 during the 2024-2025 school year that are needed to be promoted to the next grade level.

#### \*Important Remedial Credit Information

Students who took Algebra I as 8th graders and failed one or both semesters have several options for meeting the math standard required for moving to high school. If a student failed both semesters of Algebra I and the Algebra I EOC, the student should take 8th grade math in summer school and then repeat Algebra I as a 9th grader to improve their foundation skills. If a student failed only one semester of Algebra I and failed the EOC, it may be in the best interest of the student to repeat the entire course next year in 9th grade and take 8th grade math in summer school. If a student failed only one semester of Algebra I and passed the EOC, the student may take the failed semester during summer school. If a student passed Algebra I and failed the Algebra I EOC, the student may retest in June. If you have specific questions, please contact your child's counselor to review the options.

#### \*Non-Credit Physical Education (New)

The summer 2025 PE/Fitness program is designed to provide remedial students the opportunity to learn fitness health and wellness life-skills. This program is offered free to any existing middle school student enrolled in one summer 2025 remedial course. Middle school counselors will <u>automatically</u> enroll qualified students for this program during registration. *No credits will be offered for this program* 

#### Remedial Payment & Registration Information

Note: All online registration without payment is subject to being dropped without notice. Parents and students are encouraged to pay soon after the time the counselor has enrolled them in the summer school course in order to avoid being dropped from the course. Online course selections will not be held without payment. If students are dropped from the course they previously selected, the course will need to be selected again by the counselor in Family Access before payment is accepted Online. Students must complete registration form and return form to the campus counseling office before selecting and paying Online.

Students/Parents will need to pay Online with a credit/debit card through Fort Bend ISD's Family Access after the counselor has enrolled the student in the appropriate courses - go to www.fortbendisd.gov (Family Access is an icon at the bottom of the homepage). Parents/students needing assistance with registration should visit their campus counselor.

Out of district students are able to attend FBISD Remedial Summer School if their home district is not offering a summer school. An additional \$100 administrative fee will apply unless parent/guardian is able to verify residence (a utility bill may be used for verification). Out-of-District Registration will be held on June 3rd from 9-11 a.m. at Austin H.S.

Parents may contact the FBISD Customer Support Center at 281-634-1300 for Family Access assistance. Registration for all courses is on a first come first served basis and will depend on the availability of qualified teachers.

Payment must be made in by credit/debit card. Checks will not be accepted. Full payment is required at the time of registration. Refund requests will not be accepted or approved once classes begin on the first day of each session. There will be a \$25 processing fee deducted from all requested/ approved refunds, unless due to class closure by administration. Refunds may take up to four (4) weeks to process.

#### **Original Credit Programs**

• Summer Original Credit (face-to-face original credit program) Several courses will be offered. Courses are available to all students entering 9th through 12th grades who meet course prerequisites. Students may earn original credit towards graduation for classes they have not had before. This is a tuition-based program (see rates below).

• Students who failed during the regular term due to lack of attendance must repeat the course as an original credit course if offered .

• Original Credit Courses (counselor's permission required) are for students who are taking a course for the first

time or students who are repeating a course due to excessive absences or denied credit.

• Class Assignments - Classes are assigned by the summer school administrative team based on enrollment, need, and the availability of certified teachers. Courses that are canceled due to insufficient enrollment or lack of certified teachers will result in a full refund or the opportunity for the student to select another available course.

• Attendance Procedures--Efficient use of class time is essential to the student's success. Refunds will be not Given to students who are withdrawn for lack of engagement or progress in coursework.

• **Discipline Guidelines** - All students will follow the FBISD Student Code of Conduct. Students refusing to adhere to the code of conduct who receive a second (2nd) discipline referral will be withdrawn from summer school without receiving a grade for the session regardless of the date within the session will result in the student being immediately withdrawn from summer school and no refund issued.

• This action will be taken without receipt of a grade/credit for the session regardless of the date within the

#### Summer O-LAB Programs

• Rising 9th graders in good academic standing may enroll in In-District Summer O-LAB courses.

9th grade Students will take courses delivered via Edgenuity, a purchased online curriculum. The program is a hybrid program where students work from home and report to the campus to complete assessments (tests and exams). Attendance is taken at the campus the student is registered to attend the following school year (transportation is not provided). For example, if the student has been accepted to an academy, the student will attend orientation and the campus they were accepted to and not the campus to which they are zoned. The courses listed below will be offered through Summer O-Lab. Students may take up to two semesters of Online coursework. Incoming 9<sup>th</sup> grade Students may register for: Art I-A (first semester), Art I-B (second semester).

#### **Requirements for Program Eligibility:**

- Submit the application via Family Access under Online Forms
- Counselor approval and registration
- Payment submitted via Skyward Family Access

• Attend one mandatory orientation session at the campus where the student will be enrolled next school year. Dates and times TBD.

• Start the class online on the first day of summer school.

Log-in information will be provided at orientation.

• Students are required to log in daily for a minimum of two hours.

• Complete all assignments and the final exam according to the target date and time assigned to the course. Note: • Students have only one opportunity to take their cumulative exams (finals).

#### Pertinent Information:

• All grades will be posted on the student's transcript.

• All assessments (quizzes, unit tests, and exams) must be taken on campus and proctored by designated staff.

• Students must have access to a computer and stable internet access.

• All Edgenuity coursework must be completed, including final exams, by July 24th at 12:00 p.m.

Students must have an active email account to communicate with staff (preferably school email).

Students must have their own transportation.

**IMPORTANT NOTE**: Student-athletes who may be pursuing NCAA, NAIA, or NJCAA eligibility should be aware that coursework completed via online learning may not meet program requirements. UIL eligibility may also be impacted. Please contact your counselor if you have questions or concerns regarding this information.

 Incoming Rising 9th graders in good academic standing may enroll in <u>External Provider Online</u> courses.

Students may opt to take online courses via one of three outside providers approved by FBISD. <u>Counselor approval</u> is required before students register. If a student opts to use UT or Texas Tech, they must also officially register and pay the university. Students are subject to timelines, processes, and expectations set by those programs. A list of course offerings and costs for each outside provider is available through the following links. Students may register for up to two semesters of coursework.

#### Provider Options:

- Texas Virtual School Network (TxVSN) course fees vary according to the provider selected. The O-LAB teacher at the designated High School campus must assist with registration.
- University of Texas High School \$260/semester course (includes \$15 proctoring fee); Art and Spanish are \$275. Once counselor approval is received, registration occurs on the provider's website. (See the process below)
- Texas Tech University K-12 \$300/semester course.
  Once counselor approval is received, registration occurs on the provider's website. (See the process below).

#### **Registration Process**

- Registration Dates: Dates vary. Check the provider's websites.
- O-LAB External Provider Applications: Family Access -Online Forms - Directions to Family Access
- The counselor must approve the application before registration occurs on the providers website. Any credit earned without prior approval by the counselor is subject to denial by the campus.
- Once the application is approved by the campus counselor, the student/parent should register and pay for the course. Families choosing to utilize TxVSN should contact the <u>O-LAB teacher</u> at the campus.
- Students taking TXVSN, UT, or TTU courses are subject to provider deadlines.
