



# ATTIRE/BEHAVIOR CONTRACT

## I. DRESS CODE

- A. Ladies' dresses should be selected with attention to the following details:
1. Necklines with the appropriate coverage. (No low-cut or plunging necklines)
  2. The back of the dress should provide sufficient coverage so as not to fall below the natural hipline.
  3. To determine the natural hip line, a good guideline is to place one's hands on the hips and then move the hands in a straight line until the thumbs meet at the back. The back of the dress should not fall below this line.
  4. Dress length or slits should not reveal the leg six inches above the middle of the knee.
  5. **NO ONE OR TWO-PIECE DRESSES THAT EXPOSE THE MIDRIFF AREA.**  
MIDRIFF = Entire stomach area and **sides of torso. (Sides can NOT be exposed)**

- B. Gentlemen's outfits should be selected with attention to the following details:
1. Top hats or cowboy hats may not be worn inside the building.
  2. Dress shirts must be worn at all times during the dance and their pants should be worn at their waist level. The evening should reflect both class and fun.
- C. Please come dressed beautifully and appropriately. Designated administrators and teachers will determine violations in dress code. Choosing not to comply with the dress code will result in removal from the dance for the entire evening.

## II. DANCE CODE AND BEHAVIOR POLICY

By purchasing a homecoming ticket, my guest (if applicable) and I agree to abide by the rules in a respectable manner both on and off the dance floor. I understand that it is my responsibility to inform my guest (if applicable) of these policies and assure that they are followed.
