

Approved Food Truck Vendor List



All food truck approvals are valid for 1 year. Food trucks are required to submit the \$50 non-refundable vendor fee annually.

Valid insurance & permits are required to participate in any FBISD event, even if the truck is already on the approved list.

See steps below to identify food trucks cooresponding to your events

Look for your school name in the FBISD Campuses/Facilites box on the left side. You should select the food trucks listed in the same chart your school name is in. However if you want a food truck not listed in your section you can reach out to the food truck and inform them that you want to invite them but will need to obtain the proper permits.

You can request a food truck that is pending approval. The food truck can finish the approval process with the city/district before the event date if requested with time in advance.

CAMPUSES:

- 1. Check for approved food trucks that have permits where your school is located
 - > If you don't see a food truck in your area that interests you, check other approved food trucks on the list
 - > If you find one that's not listed in your area you can still invite them to your event. They MUST obtain the proper permit to operate in that area.
- 2. If the approved food truck vendor you select is not in your area and will participate in your event, please send required permit from the food truck vendor to genyne.vinson@fortbendisd.com for documentation purposes.
- 3. All food truck vendors must have proper permits for the area they are participating in or they can be shut down by that jurisdiction's health inspectors.
