Child Find & IDEA Disability Categories *presented by* Dana Walker, Educational Diagnostician

Child Find is a legal requirement that the Local Education Agency (LEA) finds all children who have disabilities and who may be entitled to special education services. Child Find covers every student from birth through age 21. The LEA must evaluate any child that it knows or suspects may have a disability.

There are 13 different disability categories as defined by the Individuals with Disabilities Education Act (IDEA), under which 3- through 22-years-olds may be eligible for services. In order to qualify for special education, the IEP Team must determine that a child has a disability in one of the 13 categories, and it must adversely affect their educational performance.

Understanding Present Levels of Performance presented by Samantha Geiger, Licensed Professional Counselor and Shelly Higgins, Deaf Education Program Specialist

The Present Levels of Academic Achievement and Functional Performance statement (PLAAFP, or "present levels") is a key part of your child's Individualized Education Program (IEP). The PLAAFP for your child describes skills and abilities based on collected data to identify the kinds and amount of special education services your child may need.

Understanding Schedule of Services & Levels of Support *presented by*Dana Walker, Educational Diagnostician

The schedule of services lists special education instructional services/support and related services your child receives. The schedule of services shows the start and end dates, frequency, and duration of a service as well as location (general or special education).

According to both state and federal law, children with disabilities must receive their education in the least restrictive environment. This means that your child must receive instruction with nondisabled peers to the maximum extent appropriate. If, however, your child's disability is so severe that education in a general education classroom is not possible, even with support, your child should receive services in a more specialized environment. The school district must offer a range of placements and supports.

Prior Written Notice & Transportation eligibility *presented by*Dana Walker, Educational Diagnostician

A Prior Written Notice (PWN) is a written explanation of a change the school district or AEA wants to make or refuses to make in a child's Individualized Educational Program (IEP).

The IEP Team is responsible for determining if transportation is required to assist a child with a disability to benefit from special education and related services, and how the transportation services should be implemented.

Extended School Year (ESY) services is an individualized instructional program for eligible students with disabilities that is provided beyond the regular school year.

House Bill 4545 establishes new requirements for accelerated instruction for students who do not pass the State of Texas Assessments of Academic Readiness (STAAR®).
