SBOE is the policy-making body of the TEA. There are 15 state SBOE members who are elected by Texans to two or four-year terms of office, and the governor appoints the chair of the board from among the elected members.

SBOE sets policies and standards for Texas public schools. The primary responsibilities of the SBOE include:

- Setting curriculum standards
- Reviewing and adopting instructional materials
- Establishing graduation requirements
- Overseeing the Texas Permanent School Fund
- Appointing board members to military reservation and special school districts
 - Providing final review of rules proposed by the State Board for Educator Certification
- Reviewing the commissioner's proposed award of new charter schools, with authority to veto a recommended applicant.

Impact on Decisions in Public School Districts and Charter Schools

The TEA, SBOE, and the State Board for Educator Certification guide and monitor activities and programs related to public education in Texas.
