
- 12. Input the contact person's information; this includes your social security number.

 - **c.** The IRS requires this as a means of contacting a person should issues arise with the organization.
 - **d.** This information can be changed each year via Form 8822-b.

- 14. Click Continue




- 15. Input the mailing address of your Booster Club.

 - **b.** Please refrain from using the school's address as they receive a large volume of mail and you may not receive notices in a timely manner.








