Transportation Review

- Eliminating routes by increasing average load
 - 50 students per run for secondary
 - 60 students per run for elementary
- Decreasing route mileage by increasing the student walk-to-stop
 - Up to ½ mile for secondary students
 - Up to 1000 feet for elementary students



Transportation Review

- Shifting bell schedules to improve the routing efficiency
 - Elementary 8:10 to 3:10
 - Middle School 8:55 to 3:55
 - High School remains unchanged
- Reviewing all hazardous areas within two-miles of schools; eliminating service in areas that do not meet conditions for hazardous area service



Pay Transportation

- Currently we have 222 riders across the district paying \$27 a month.
 - 126 pay riders are elementary students
- There are 7 runs dedicated to just pay riders.
 - 109 students on those seven runs
 - \$20,000 a year loss
- Recommend canceling the program



After School Runs

General Activity Runs

- HS has 48 runs with 728 riders (4 days a week)
 - \$311,000 this year
- MS has 46 runs with 735 riders (4.2 days a week)
 - \$311,000 this year

Tutorial Runs after school

- HS has 5 runs with 77 riders (3.2 days a week)
- MS has 27 runs with 418 riders (2.5 days a week)
- ES has 8 runs with 214 riders (2.4 days a week)



Hazardous Area Review

- Eliminate service in areas that do not meet conditions for hazardous area service
- ES #45 no safe passage across highway 521
 - All areas to be bused
- Ridge Point High School no hazardous areas within the 2 mile walk zone
 - No bus service in the walk zone

Transportation Savings

- Reduction of 42 routes
 - \$1.6 million
- Eliminating general activity after-school runs
 - **\$622,000**
- Cancel Pay Transportation program
 - **\$20,000**
- Hazardous Area review
 - Saves mileage on equipment and captured in overall route reduction savings.
